



## CHARTER TERMS

Please keep this page for your records – You are responsible for knowing and complying with the rules/conditions of this charter.

**THESE RULES APPLY TO ALL CHARTERS WHICH INCLUDE WEDDINGS, PROMS, BACHELOR, BACHELORETTE PARTIES, AIRPORT, POINT TO POINT & ANY OTHER SPECIAL EVENTS.**

1. B.E.T Limousine agrees to provide the designated vehicle and a professional driver at the time, date and location specified on the contract
2. Unless specified on the contract, request for additional hours on the day of the event will be provided only if the vehicle is available and an applicable fee will be charged for the additional time.
3. B.E.T Limousine reserves the right to substitute a vehicle of equal or greater value in the event of mechanical difficulties or scheduling conflicts.
4. The number of passengers allowed in the vehicle shall be no more than the number specified on the contract or limited to the vehicle passenger capacity it is designed to carry.
5. B.E.T Limousine and its employees are not responsible for any unattended, forgotten, left, lost, damaged or stolen articles at any time in the vehicle.
6. The sale or use of **ILLEGAL DRUGS**, or smoking in the vehicle is strictly forbidden. Also alcohol consumption or possession by minors is strictly forbidden. There will be no standing out of the moon roofs or hanging out of windows. B.E.T Limousine reserves the right to immediately terminate service without any refund to any party or person(s) who violate these rules.
7. All tolls (ETR 407) and parking fees are not included in the rental rate.
8. There will be a \$10.00 (ten dollar) charge for any broken or missing glassware.
9. Overtime will be billed in half hour increments and will be billed to the customer at the contracted rated. Customer agrees to pay any overtime charges.
10. Customer accepts full responsibility for vehicle damage or special cleaning and any loss of income due to negligence and carelessness caused by any member of the customer's group or customer. (Examples: Vehicle damages caused from smoking, burns, vomiting, scratches, broken glassware, stains, wrestling in vehicles, kicking windows/mirrors etc.) and authorizes B.E.T. Limousine to charge the guaranteeing credit card for the expenses regardless and in addition to prior understanding and agreements. These charges are necessary due to the high costs of cleaning and the revenue and time lost because the car cannot be used. If the guaranteeing credit card cannot be charged for any reason, customer agrees to pay for damages within seven days from the event date. Customer agrees to pay for any collection expenses and/or attorney fees and costs associated with B.E.T Limousine's collection efforts
11. FAILURE OF CUSTOMER TO COMPLY WITH THESE RULES AND REGULATIONS WILL RESULT IN TERMINATION OF SERVICE, REQUIRING PAYMENT IN FULL WITH NO REFUND.
